ADOPTION OF AGENDA

Mr. Patrick Hurley moved to approve the agenda and Dr. Nat White seconded the motion. The agenda was approved as presented.

Mr. Patrick Hurley moved to approve the Consent Agenda and Dr. Nat White seconded the motion. The motion was unanimously approved.

FOLLOW UP ITEMS

Ms. Patricia Garcia reviewed the follow up items with the Board. The mission item is ongoing and Dr. Smith sent the Board information on proposed ballot initiatives.

INTRODUCTION OF GUESTS

Mr. Scott Talboom introduced Ms. Suzanne Adams-Ockrassa, Mr. Steve Peru, Mr. Greg Jay, and Ms. Gail Lowe.

CALL TO THE PUBLIC

Mr. Steve Peru responded to the Call to the Public. Mr. Peru spoke to the Board as a citizen of Coconino County. His remarks focused on his support for the College and community colleges in general; his disappointment that the College has not been successful in efforts to pass an override election; and the formation of an outside group (Community Champions for Coconino Community College) to support the College as an important part of the community. The vision of this group is to create awareness and support for the College throughout Coconino County.

In addition to Community Champions for CCC, community members have formed an advocacy group (Citizens for a Thriving CCC) and have filed paperwork with Coconino County to formalize the organization.

Mr. Peru is hopeful that these group will support the work of the institution and assist with community support for the College. The College is an important member of the community and Mr. Peru wanted the Board to know that there is support for the College in the community.

ACTION ITEMS

Acceptance of Fiscal Year 2017 Comprehensive Annual Financial Report, Single Audit, and Expenditure Limitation Reports – Ms. Jami Van Ess

Ms. Jami Van Ess presented the agenda item and introduced the various documents presented to the Board as part of the audit process. Ms. Van Ess acknowledged Ms. Siri Mullaney and everyone throughout the College who worked to make this a successful audit.

Mr. Jay Zsorey, the Financial Audit Director and Mr. David Glennon, the Financial Audit Manager from the Arizona Auditor General's Office joined the board and answered questions related to the audit.

Mr. Zsorey congratulated the college on a clean audit. He stated that this result shows that the College is doing a good job in producing financial statements and in our system for awarding financial aid. There was a new focus on increasing internal controls in the areas of information technology and security student information in this year's audit process.

Mr. David Glennon congratulated the College on being the first community college to issue a complete audit report. He also thanked the district for their assistance in completing the audit so quickly. Mr. Glennon reviewed the audit documents with the Board. The Board asked questions about the focus on information technology areas and the specific direction needed to respond to the audit findings.

Ms. Jami Van Ess recommended that the District Governing Board accept the Comprehensive Annual Financial Report, Single Audit, and Expenditure Limitation reports for Fiscal Year 2017.

Dr. Nat White made a motion to accept the recommendation. Mr. Patrick Hurley seconded the motion and it was unanimously approved.

The Board congratulated Ms. Van Ess and thanked her for her work in this area.

Election of Board Chair, Vice Chair/Secretary, and Committee Representatives

The floor was opened for nominations for Chair. Mr. Lloyd Hammonds nominated Ms. Patricia Garcia and Dr. Nat White seconded the motion. There were no other nominations so the nominations were closed. The motion was unanimously approved and Ms. Patricia Garcia was elected Chair.

The floor was opened for nominations for Vice Chair/Secretary. Ms. Patricia Garcia nominated Mr. Lloyd Hammonds. Dr. Nat White seconded the motion. There were no other nominations so the nominations were closed. The motion was unanimously approved and Mr. Lloyd Hammonds was elected Vice Chair/Secretary.

The board then moved to appoint committee representatives. The current AADGB representative is Mr. Lloyd Hammonds and he is willing to continue to serve with AADGB. Mr. Patrick Hurley nominated Mr. Lloyd Hammonds and Dr. Nat White seconded the nomination. The motion was unanimously approved.

The current Alliance representative is Mr. Patrick Hurley and he is willing to continue to serve. Ms. Patricia Garcia nominated Mr. Patrick Hurley and Mr. Lloyd Hammonds seconded the motion. The motion was unanimously approved and Mr. Patrick Hurley was elected Alliance Representative.

The current Foundation Board Representative is Dr. Nat White and he is willing to continue in this role. Ms. Patricia Garcia nominated Dr. Nat White. Mr. Lloyd Hammonds seconded the motion. The motion was unanimously approved and Dr. Nat White was elected Foundation Board Representative.

INFORMATION REPORTS

Dr. Nat White asked Mr. Scott Talboom to report on the most recent Foundation Board meeting. The Foundation Board has been focusing on recruitment of new members and several new members have joined the Board. The Finance Committee is working on finding a new financial firm to manage the Foundation's assets and the Strategic Planning Committee is developing a new strategic plan.

Academic Affairs and Student Engagement - Dr. Dudley Gardner

Dr. Dudley Gardner asked Ms. Veronica Hipolito to introduce Juanita Tarango, Director of Student Success and Access. Dr. Gardner talked about changes in enrollment including an increase in online enrollment. The College is beginning to see return on the efforts to attract new students and retain existing students.
