**ADOPTION OF AGENDA**

**PRESENTATION OF PROPOSED 2026/2027 BUDGET FOR CONSIDERATION BY THE RESIDENTS AND TAXPAYERS OF THE DISTRICT – Dr. Van Ess**

Dr. Van Ess presented the proposed Fiscal Year 2027 budget for consideration and explained the contents of each of the four main areas of the College's budget. The District's budget for fiscal year 2027 totals \$58,449,529 for all funds. It reflects the financial plan of support for the College's educational services through four separate fund groups.

The **General Fund** amounts to \$ 35,217,901. It accounts for the resources and expenditures of the College's general instructional, academic, student services, administration, and maintenance, and operations.

The **Restricted Fund** budget is \$9,405,050, which accounts for federal, state, and local grant programs.

The **Auxiliary Fund** budget total is \$384,022, which includes the student activity fees, athletics, bookstore, calculator rental, and vending.

The **Plant Fund** budget is \$13,442,556, which provides for the planned maintenance of the District's campuses and capital equipment expenditures.
