The *Senior Citizen Tuition Waiver* is for Arizona residents who are **65 years of age and older**. This waiver reduces tuition by 25% for up to six credit hours. Non-credit classes, fees, books and class materials must be paid in full and are not paid for with this waiver. Please complete the CCC admissions application and domicile affidavit and register for classes before completing this application. This application must be received prior to or during the semester the tuition waiver has been requested.
