If I withdraw from school, the balance, at the option of Coconino Community College is payable immediately. I further agree to pay any and all collection costs, attorney's fees and court costs incurred by the holder of this note to collect any default in the payment of this note. I also understand and accept the following provisions:

Should it subsequently be determined by the Department of Veterans Affairs that I am not eligible for benefits, interest at the rate of 10% per annum will accrue on the principal amount listed below from the first date of this note. I will be responsible for the payment of the principal and any interest accrued.
